

### The Ministry of Tourism shall assume inspection of the following

- Tourism licensing
- Permits for using artist groups.
- Permits for serving alcoholic drinks.
- Quality of equipment and furnishing within the facility.
- General cleanliness of all facility areas (of the guests and clients, of the employees, of the facility).
- General cleanliness in the entire outside area of the facility.
- Compliance with the license status granted to the facility.
- Compliance with the working hours of tourist restaurants of all categories.
- Compliance of workers in the tourism facilities with their assigned uniform.
- Announcement of prices.
- First aid.



When recording notes on the facility for the first time, it is contacted to address the comments within a specific period and follow them up.



After follow-up for the second time and the discovery that the comments were not addressed, the matter is submitted to the Tourism Committee to send a warning pursuant to article "11/a" of the Tourism Law.



When recording notes on the facility on his third visit, the matter shall be submitted to the Tourism Committee to suspend the professional practice of the facility and its reception of clients until the comments are addressed pursuant to article "11/a/1" of the Tourism Law.

### The Ministry of Health / Food and Drug Administration shall assume inspection of the following

- Staff health certificates.
- Food items storage.
- Food items validity.
- Food items warehouses.
- Cleanliness of food items preparation area.
- Food items packaging and storage.
- Refrigerator temperatures (thermometers).
- Staff sound and healthy interaction with food items.
- Staff personal hygiene within kitchens and preparation areas.
- Food items storage methods, both frozen and refrigerated.
- Methods of using frozen food items.



\* Pursuant to Food Monitoring Law no 79 of 2001, the following penalty is applied:

1. Paid violation.
2. Referral to Magistrate Court.
3. Precautionary shut down.
4. Fine.
5. Stakeholder's imprisonment.
6. Or both penalties in 4 and 5.

### **The Ministry of Labor shall assume inspection of the following**

- Work permits for non-Jordanians.
- Work within the profession specified in the permit.
- Work for the same sponsor.

- Pursuant to Labor Law no 8 of 1996, the following penalty is applied:
  1. Guidance and counseling.
  2. Written warning.
  3. Violation and referral to judiciary.

### **The Greater Amman Municipality shall assume inspection of the following**

- Taking random routine samples from food items prepared for laboratory testing.
- Staff health certificates.
- Food items storage.
- Food items validity.
- Food items warehouses.
- Cleanliness of food items preparation area.
- Food items packaging and storage.
- Refrigerator temperatures (thermometers).
- Staff sound and healthy interaction with food items.
- Staff personal hygiene within kitchens and preparation areas.
- Food items storage methods, both frozen and refrigerated.
- Methods of using frozen food items.
- Professional license.
- Utilization of recesses.
- Change in license status.

- Pursuant to Labor Law no 8 of 1996, the following penalty is applied:
  1. Written warning.
  2. Violation paid in the court.
  3. Violation with work suspension.
  4. Violation with precautionary closure.

### **The Civil Defense Directorate shall assume inspection of the following**

**Public prevention and safety requirements.**

*(Fire extinguishers, fire hoses, emergency exits ...)*
